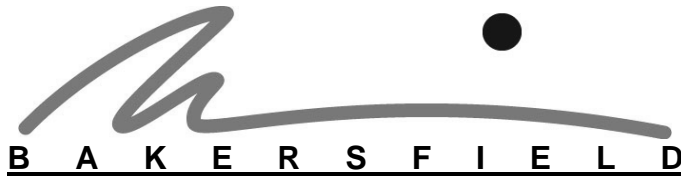




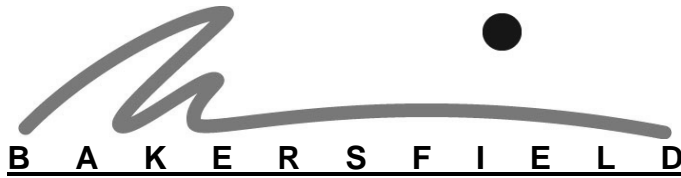

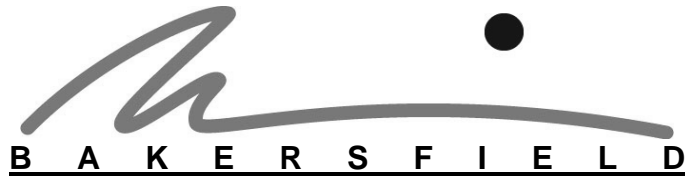

DEVELOPMENT IMPACT FEES

HABITAT CONSERVATION \$ 2,145 per gross acre

Payment of this fee shall occur before any grading or other land disturbance takes place on the site. Please contact the Planning Department if you have any questions (phone 661/326-3733).

PARK \$ 1,615 per residential unit

Fee applies to all independent dwelling units (includes senior housing). It does not apply to facilities such as extended care where the units do not contain a kitchen. Please contact the Planning Department if you have any questions (phone 661/326-3733).

SCHOOL

- Residential \$ 2.97 - \$ 4.95 per square foot
- Commercial / Industrial \$ 0.47 per square foot

Fees vary widely by school district. Please contact the Kern Superintendent of Schools (phone 661/636-4000) or the Building Department (phone 661/326-3727) to determine which district your project is located and the fee they are currently assessing.

SEWER

Residential

- Single Family \$ 3,700 per unit
- Multiple Family (1 bathroom) \$ 2,355 per unit
- Multiple Family (2 or more bathrooms) \$ 2,664 per unit

Commercial/Industrial

- All except food preparation and markets requiring grease trap \$ 168 per fixture unit

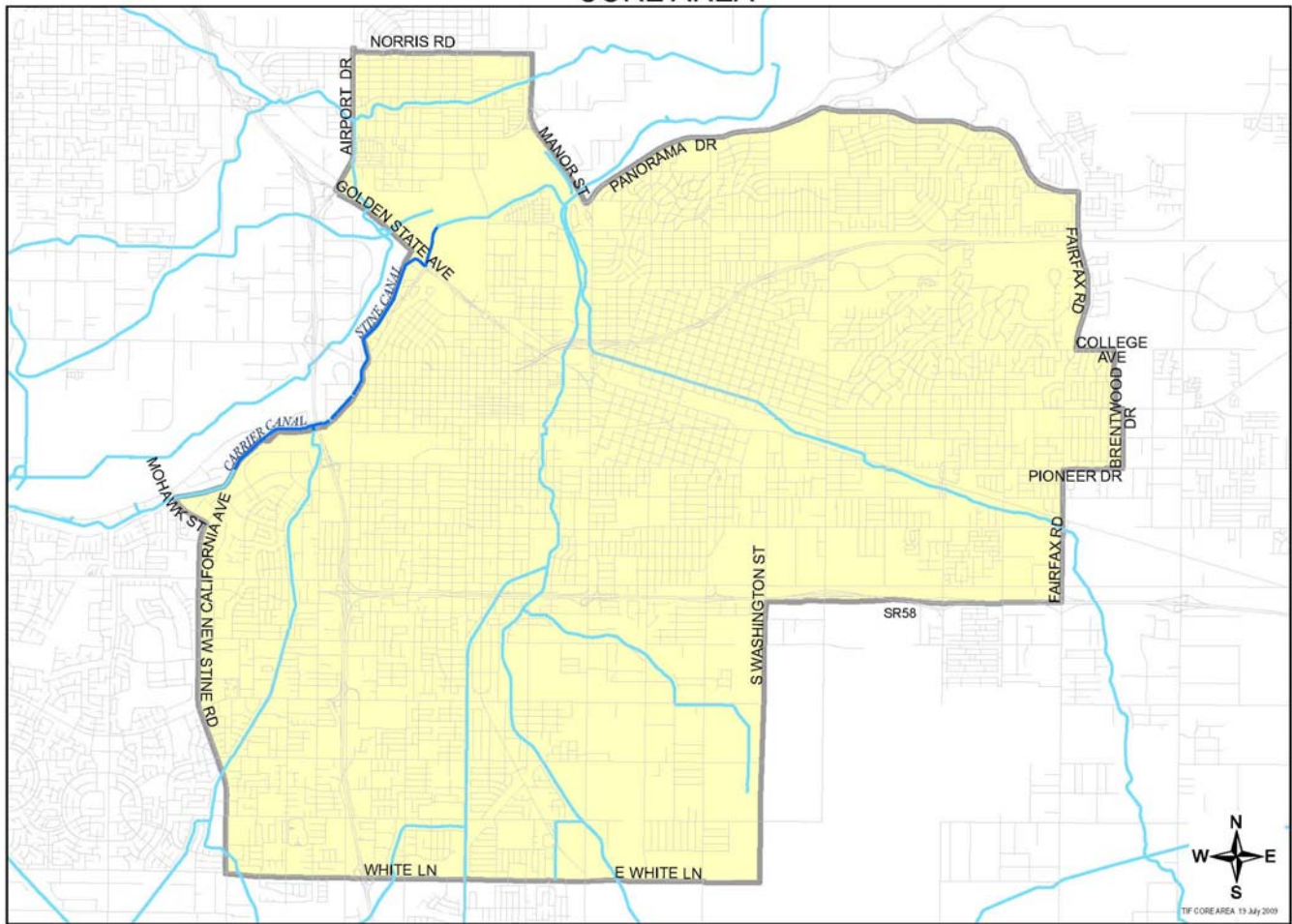

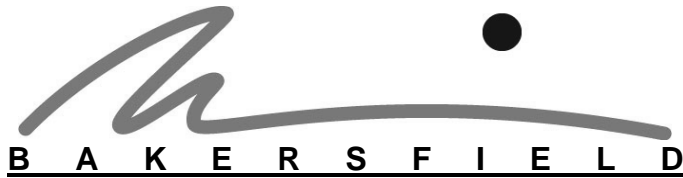

BUILDING PERMIT \$ 52 minimum + project valuation

This is the minimum fee for a building permit based on the valuation of the project. The fee includes structural, mechanical, plumbing, and electrical permits, inspections, and plan review. Please contact the Building Department to obtain the actual fee for your project (phone 661/326-3727).

CONDITIONS OF APPROVAL/COMPLIANCE \$ 40 per permit
(applies to all building permits issued within Specific Plan areas, and PUD/PCD zoned areas)

GENERAL PLAN MAINTENANCE (added to building permit fee for new construction)..... \$ 78

SIGN PERMIT (separate permit from a Building Permit)

- Permanent..... \$ 104
- Face changes / Temporary signs / Banners \$ 52

STRONG MOTION INSTRUMENTATION (seismic – added to building permit fee)
