3. First day to file Nomination Papers Requires no less than 20 nor more than 30 signatures. (E.C. §10220, §10224, §10407- 113 th day prior to Election)	July 18, 2016
4. Last day to submit Resolution to County Board of Supervisors and County Clerk calling election and requesting consolidation (E.C. §10403)	August 12, 2016
5. Last day to file Nomination Papers and Candidate Statements. Must be filed concurrently. (88 th day prior to Election - E.C. §10220, §10224, §10407, §13307)	August 12, 2016
6. Last day for candidates to withdraw his/her Nomination papers, excluding extended filing period. (E.C. §10224)	August 12, 2016
7. Last day to withdraw Candidate's Statement. May not be altered or changed once filed. (Resolution No. 47-83, E.C. §13307, §13311)	August 15, 2016
8. First day of extension period for Nomination Papers to be filed. (Applicable <u>only</u> for Non-incumbent , when the incumbent does not file by the deadline (E.C. §10225, §10407)	August 15, 2016
9. Last day to file Nomination Papers and Candidate Statements under the extension period provision. Must be filed concurrently (83 rd day prior to Election, E.C. §10224, §10225)	August 17, 2016
10. Last day for candidates to withdraw his/her Nomination papers filed under the extension period provision (E.C. §10225)	August 17, 2016
11. Last day to withdraw Candidates' Statement filed under the extension period provision (E.C. §13307)	August 18, 2016
12. Randomized Alphabet Drawing by Secretary of State (82 nd day prior to Election. E.C. §13112, §13113)	August 18, 2016

13. Last day for City Clerk to certify and file with Kern County the List of Candidates (81 st day prior to election G.C. §6066, E.C. §10403)	August 19, 2016
14. Publication of List of Nominees as they shall appear on the ballot (Publish once a week, for two successive weeks, and no later than the 7 th day prior to Election. G.C. §6066, E.C. §12110)	August 29, 2016 September 5, 2016
15. First day filing period for Write-In Candidates , (E.C. §8600-8604, §10103, §10220)	September 12, 2016
16. First Pre-Election Campaign Statement due to City Clerk (Filing Officer) *	September 29, 2016
17. Last day to Register to Vote for the November election.	October 24, 2016
18. Last day to file as a Write-in Candidate and file Nomination Petitions (E.C. §8600-8604, §10103, §10220)	October 25, 2016
19. Second Pre-Election Campaign Statement due to City Clerk *	October 27, 2016
20. ELECTION DAY	November 8, 2016
21. Kern County to Canvass Election Returns (E.C. §10411, §10262(b), §10263(b), §15372)	November 9, 2016- December 9, 2016
